## The Pres Says...

Happy New Year! I am excited about assuming presidency of this organization at such a critical time in the history of the League and the GOP in Hawaii. I have been reviewing the extensive files and learned that the League was founded by Mrs. Elizabeth Farrington, wife of the Territory of Hawaii's congressional delegate. Mrs. Farrington was president of the Washington (D.C.) League of Republican Women and thought Hawaii would benefit from having such a group here. She had no trouble persuading ten women on Oahu to come together to form the Oahu League. A charter was obtained from the Washington group and when clubs formed on the islands of Hawaii, Maui, Kauai and Molokai, the Oahu League joined with them to become one group, affiliated as a state federation. Mrs. Farrington became the first president of the Oahu League, and later, before her death, honorary president for life. We have had 24 presidents since 1946. While the number of members has fluctuated over the years, we currently have over 200 members.

An early accomplishment of the Oahu League was a successful series of "schools of politics." This school trained individuals who were running for precinct president or district chairman, public or party office. Commencement exercises with diplomas were given and signed by the Republican National Committee (RNC).

In 1974 a resolution prepared by then Senator Fred Rolfing authorized the study of means by which the Republican Party of Hawaii could acquire a permanent headquarters. The resolution passed in convention, but by 1976, even the concept itself was abandoned by both the Republican Party and the Oahu League. In comes Martha Daniels, who joined Oahu League in 1954, and became a Life Member in 1974. She wanted to League to have a permanent home so she prepared a trust which provided several hundred thousand dollars to pay for a building only, not land, which then required the League to partner with another organization to secure a place. She gave the League 10 years to find a home after her passing in March 1989 at the age of 99 years.

In March 1998, the Republican Party, chaired by Donna Alcantara, and the Oahu League, presided over by Helen Kekuna, talked over dinner one night and came up with the brilliant plan to purchase the headquarters for both organizations. The stipulation in the trust allowed the League 50/50 ownership with the GOP in the building or space, but the GOP would hold title to the land and is responsible to pay the mortgage. An agreement dated August 14, 1998 specifically states that:

The Republican Party agrees to make all payments due and owing to maintain ownership of the building and the land (meaning they are obligated to make sure they don't default). In consideration of the Oahu League's contribution to the purchase of the building the Republican party will hold the Oahu League harmless from any payments for the support of the building. (They cannot look to us to help them pay the mortgage and overhead to support the HQ). Further the Republican Party will provide permanent office space for the Oahu League within the building. (We get a key.) Neither the Republican party or the Oahu League shall have the right to sell, or transfer any or all of their portion of the property without the agreement and concurrence of the other. (The party was reminded of this last provision when party officials revealed they had been looking to sell and find smaller quarters because of the financial situation that appears to be facing the Party.)

Leave it to the women to come up with this plan, especially since the men in the early years didn't take too well to women getting involved in the smoky backroom political deal making which they regarded as their kuleana! I remember those days back in college, same attitude and the room really was full of smoke!! So 24 years after Fred Rolfing started the idea, and ten years after the passing of Martha Daniels and her generous gift, the Oahu League of Republican Women and Hawaii Republican Party joined together in one place, our home at 725 Kapiolani Boulevard.
