Lieutenant Colonel Pierce was born in Bucyrus, Ohio. In addition to graduating summa cum laude from her undergraduate nursing program she earned undergraduate degrees in both Psychology and Sociology. She completed her Master's Degree in Human Resource Management



in 2004. After 12 years of civilian nursing experience she was commissioned into the United States Air Force Nurse in 1991. As a Nurse Corps Officer, she has held a variety of command and squadron-level assignments with an emphasis on clinical operations and human resource management. Most recently she served as Commander, 15th Medical Operations Squadron, Hickam AFB Hawaii during the eight month deployment of the assigned commander. Prior to her assignment to the 15th Medical Group, Lt Col Pierce served as 22nd Medical Operations Commander and Chief Nurse for the 22nd Medical Group, McConnell AFB Kansas where she was responsible for outpatient services consisting of Primary Care, Pediatrics, Immunizations, Women's Health, Physical Therapy, Radiology, Life Skills, Family Advocacy, and the Demand Reduction Programs serving 22K beneficiaries. During 2007, Lt Col Pierce deployed as Chief Nurse for Task Force Med and Deputy Commander to the 455 Expeditionary Medical Operations Squadron for Craig Joint Theater Hospital, Bagram Air Base Afghanistan. There she assisted in the oversight of more than 100 personnel and all facets of medical operations while leading Nursing Services for the facility and seven forward operating bases throughout Afghanistan. Lt Col Pierce is board certified in both Healthcare Quality and Ambulatory Nursing Care. She is married to Michael Pierce and together they have two beagles still living at home.



The Pres Says...

Your League was treated to a real alternative view of how to balance the state budget with Lowell Kalapa's presentation at our April luncheon. Lowell regularly testifies at the legislature that there is an other way to balance the budget without raising taxes. The government budgeting process can be very complicated and our elected officials are masters at ingenious ways to get money for whatever they want and label it as something else to hide the real purpose. Trouble is, when the revenues plummet, all that money hidden under the mattress, like special funds, is exposed for what it is, a slush fund for somebody's pet project whose real costs are hidden from those paying the bills, us.

I attended the Balanced Budget Seminar put on by the Republican House Caucus and Senator "Lone Ranger" Slom this last Wednesday morning, the 20th. It was sparsely attended, maybe 50 people, including a couple Democrats, staff members and the "usual suspects," like me and Panos. Senator Slom, who will be our June speaker, noted that 25% of the state's economy is state government. That's too much. He said a fundamental change in political philosophy is needed, away from the belief that the government is the providor of all that is good in the world. He noted that union contracts are unilaterally negotiated by the governor, favor the union bosses, and no one speaks for the group that is footing the outrageous bill, the taxpayers. (Well, he sure speaks out, and that is what the Tea Party movement is all about.) For more information, go to www.hawaiisenatewatchdog.org

Sen. Slom then introduced Jonathan Williams, a tax economist from the American Legislative Exchange Council (ALEC), who was brought in by the House Republican caucus. The ALEC is a non-partisan think tank that advises legislatures nationwide on how to run a more efficient, more effective government. Williams noted that 45 out of 50 states are facing budget shortfalls and the nation is looking at \$3,000,000,000,000 in unfunded pension obligations. That's \$3 trillion, a trillion has 12 zeroes. He is a co-author with Arthur Laffer and Stephen Moore of Rich States Poor States, which you can buy on line or just read at www.alec.org/AM/Template.cfm?Section=Rich States Poor States . Williams noted that states are finding out the hard way that the so-called stimulus funds mandated more accounting effort than the money was worth. Speaking of accounting, he said the government uses its own accounting system which, I suspect, if it was used by a private company would land somebody in prison. Copies of ALEC's State Budget Reform Toolkit were available. The Toolkit suggests 23 reforms. One was having priority based budgeting based on government's core responsibilities, ex. defense, safety, protection. Government agencies should have mission statements. What's their purpose, are they fulfilling it efficiently and effectively? There should be a "Budget Transparency Requirement"...no money under mattresses anymore. Every bill should have "fiscal notes" appended to them, estimating how much money any bill will drain from the free market economy, not how much the government will I would also suggest every bill have a Liberty Transparency Requirement: does a proposed bill get. encumber or liberate the citizens? If it encumbers, is the justification rational and agreed upon by a majority of the citizens? For example, criminal activity obviously punishes behavior we all agree is not to be tolerated..but the size, shape and color of signage of someone's small business, maybe not so much.

There are solutions beyond tax and spend, and spend and spend.
