School construction should be based on student needs, not politics

The Legislature is about to sentence the children of West Oahu to grossly overcrowded classrooms and campuses for the next decade and beyond, by foolishly expending money on a new high school in Maui where enrollment numbers are substantially dropping.

Gov. David Ige requested \$31 million in his budget for a new building at Campbell High School to accommodate the exploding student population. He did not request a penny for a new high school in Maui, which clearly indicates it is not a DOE priority and not a needed expenditure. Yet the politicians are putting unneeded pork ahead of critical student needs. This is shameful and business as usual.

The DOE's own enrollment numbers and projections are clear: West Oahu is in urgent need of a new high school. The governor's proposed building for Campbell is an emergency measure in response to decades of poor planning.

To add insult to injury, the House just slashed it by half to \$15 million, while appropriating \$37 million for a new high school in Kihei that is not needed; enrollment there (Maui/Baldwin) is projected to decline by 409 students while West Oahu (Campbell/Kapolei) is Kurt Fevella is a long-time Campbell High School alumnus, and president of the Ewa Beach Lions Club. predicted to rise by 769 students. Even more remarkable is that the Senate allocated zero dollars for Campbell and upped the Maui appropriation to \$38 million. What are we doing?

State Rep. Bob McDermott has demonstrated that DOE Superintendent Kathryn Matayoshi has not provided strong guidance to the Legislature with regards to the No. 1 priority for a new high school; instead she has been a muted political puppet worried about offending powerful politicians instead of putting the children's interests first.

This has allowed legislators to put their wants and desires before the needs of our school children. The Department of Education should be making recommendations on where new construction is really needed, based on enrollment projections and hard data.

The expenditure of huge sums of money for a new high school on Maui would handcuff the DOE for years. And though the governor finally recently released a long-dormant \$5 million appropriation for design and construction of the new West Oahu High school, we do not have the money to build two new high schools at once. Further, this is a pyrrhic victory as this superintendent does not even have a site selected for the West Oahu school. No work can begin until they pick a site. The numbers say a Kihei high school is not needed, not to mention the huge operational costs of another high school being layered onto an already thinly stretched DOE budget. Once built, implementation of the student weighted formula will cause Maui and Baldwin high schools to have anemic funding levels due to the transfer of students to Kihei, meaning loss of teachers, programs and extracurricular activities.

My heart is for the children of Oahu's west side who are already in hot, overcrowded classrooms.

Today, Campbell has 3,086 students and, according to the DOE, will grow to 3,545, in 2020. Yet, the politicians want to build a high school where enrollment is falling. It is time we put the children first with child-centered policies and not political pork



## Edna's Challenge

We have to start taking our responsibility to our candidate seriously. ## May is Military Appreciation Month

Congress designated May as National Military Appreciation Month in 1999 to ensure the nation was given the opportunity to publically demonstrate their appreciation for the sacrifices and successes made by our servicemembers - past and present. Each year the president makes a proclamation, reminding Americans of the important



role the U.S. Armed Forces have played in the history and development of our country.

#### Armed Forces Day 21

Armed Forces Day is a day to recognize members of the Armed Forces that are currently serving. In 1947, the Armed Forces of the US were united under one department which was renamed the Department of Defense in 1949. President Harry S. Truman supported the creation of a day for the nation to unite in support and recognition or our military members and their families. On August 31, 1949, Secretary of Defense Louis Johnson announced that Armed Forces Day would take the place of other individual branch celebrations, and all branches of the military would be honored this single day. Armed Forces Day takes place on the third Saturday in May.

#### Memorial Day 30

Memorial Day started as an event to honor Union soldiers, who had died during the American Civil War. It was inspired by the way people in the Southern states honored their dead. After World War I. it was extended to include all men and women, who died in any war or military action.



It is traditional to fly the flag of the United States

at half staff from dawn until noon. Many people visit cemeteries and memorials, particularly to honor those who have died in military service. Many volunteers place an American flag on each grave in national cemeteries. Memorial Day is combined with Jefferson Davis' Birthday in Mississippi.

Memorial Day has become less of an occasion of remembrance. Many people choose to hold picnics, sports events and family gatherings on this weekend. This day is traditionally seen as the start of the summer season for cultural events. For the fashion conscious, it is seen as acceptable to wear white clothing, particularly shoes from Memorial Day until Labor Day. However, fewer and fewer people follow this rule and many wear white clothing throughout the year.

Memorial Day was originally known as Decoration Day. The current name for this day did not come into use until after World War II. Decoration Day and then Memorial Day used to be held on May 30, regardless of the day of the week, on which it fell. In 1968, the Uniform Holidays Bill was passed as part of a move to use federal holidays to create three-day weekends. This meant that that, from 1971, Memorial Day holiday has been officially observed on the last Monday in May. However, it took a longer period for all American states to recognize the new date.



## Other SPECIAL DAYS in May

## May Day

May Day marks the halfway point between the first day of spring and the summer solstice. May Day dates back to the days of the Romans and involved many pagan rituals and ancient customs which were slowly phased out with the arrival of Christianity. Festivals, dances, and rituals related to agriculture and fertility were practiced by many Germanic and European countries.

#### National Teacher's Day 3

National Teacher Day provides an opportunity to recognize and

show appreciation for the enormous impact that this nation's teachers have made and continue to make on its youth.



In 1953, an Arkansas teacher wrote to Eleanor Roosevelt about the need to recognize and honor the nation's teachers. Mrs. Roosevelt persuaded Congress to proclaim a day in May as National Teacher Day. National Teacher Day is celebrated on Tuesday of National Teacher Week; this week is observed the first full school week of May each year.

#### Cinco de Mayo 5

Cinco de Mayo is a celebration of the Mexican Army's victory over France during the Franco-Mexican War. During Mexico's war with France, the US was engaged in its Civil War. Cinco de Mayo celebrates the Mexican victory at the Battle of Puebla. This battle was a significant turning point for the US as well. The French were US Confederate Army supporters. During the Battle of Puebla, their attention became so focused on the battle with Mexico that the US Union Army forces were able to advance and gain significant ground. It is considered a minor holiday inside Mexico however, in the US, Cinco de Mayo not only celebrates the victory at the Battle of Puebla, but also serves as a celebration of the culture and heritage of the Mexican people.

#### Mother's Day 8

Mother's Day is a day dedicated to honoring and recognizing the sacrifices and accomplishments of mothers. Mothers are recognized by family and friends; regardless of whether they are biological or perceived maternal figures. It is a day to honor and respect mothers for their many sacrifices; a day to



show them how important they are to us. In 1914, Woodrow Wilson signed a proclamation recognizing the second Sunday in May as Mother's Day

## Puerto Rico blamed Jones Act for its woes

Few people I know in Hawaii are aware that Puerto Rico has declared itself "bankrupt."

Even fewer know that government leaders there blame the Jones Act restrictions for causing their bankrupt condition.

Puerto Rico sought relief through the U.S. Supreme Court after the commonwealth government there was told by a U.S. District Court that it could not amend its bankruptcy laws.

Officials attempted legislatively to comport Puerto Rican law with the latitude allowed the states. The U.S. Supreme Court found favorably, allowing Puerto Rico to amend its governmental agencies' bankruptcy provisions.

While Hawaii is not bankrupt at this time, Hawaii is headed in the same direction as Puerto Rico. Because of the fragile economy, increased homelessness, limited agricultural production and high government spending, we must address the solutions rather than discuss the problems.

If Hawaii were given relief from the Jones Act, our state's economy could parallel or exceed the economies of Singapore and Hong Kong.
