

Brigadier General Suzanne Vares-Lum

On January 13, 2016, The Hawaii Midweek featured Colonel Vares-Lum's promotion on pinning to Brigadier General. The pinning ceremony was conducted on December 15, 2015 in coordination with the promotion of Brigadier General Kenneth Hara at Washington Place. Having served for more than two decades, she was honored as the first female Brigadier General of Native Hawaiian Ancestry in the United States Army.

Brigadier General Suzanne Vares-Lum has become a symbol for young local female Soldiers who have witnessed her professionalism, hard work, and



love for family, service, and her Soldiers meet a tremendous achievement.

On April 21, 2016, Brigadier General Suzanne Vares-Lum was honored by her Almamater, the University of Hawaii by being inducted into their General Officer Hall of Fame. Suzanne, is the first female of the University of Hawaii ROTC program to achieve the rank of General Officer and the 18th overall to graduate from the UH ROTC program.

Brigadier General Suzanne Vares-Lum currently serves as the Mobilization Assistant to Director of Strategic Plans and Policy, U.S. Pacific Command at Camp Smith, Hawaii. She has a key role in the Pacific Command's effort to shape and maintain regional security through development of diplomatic, economic, and military policies. This includes building and maintaining military-to-military and political-military relationships among the 43 nations within the Pacific region covering over 51% of the globe. Activities include disaster management, humanitarian assistance, homeland defense, appropriate oversight of reserve component matters, and, as a senior leader within the directorate, oversight of strategy and policy issues that influence the Pacific region.

SPECIAL DAYS in June

14 Flag Day

Flag Day celebrations began to be held around the country with the first celebration held in Chicago, Illinois on June 16th, 1894, the third Saturday of the month. More than 300,000 children attended the celebration. During the following years, Flag Day

celebrations continued to be observed on the third Saturday of the month of June.

As June 14th was the day the Second Continental Congress officially declared the national flag to be the Stars and Stripes, it was agreed upon by many governors and delegates in the early 1900's that June 14th of each year should be nationally adopted as the official Flag Day of the nation. In 1916, ".President Woodrow Wilson issued a proclamation establishing Flag Day as an annual national event." 11 Thirty-three years later in August of 1949, Harry S. Truman signed into law the National Flag Day observance to occur on June 14th of each year. The National Flag Day observance is not a federal holiday; it is just an observance.

Controversy

Historians throughout the years have not been able to prove that Betsy Ross was the person who created the flag or sewed the flag. As there is no written proof of an invoice or a payment to Betsy Ross for the sewing of the flag, the only information recorded comes from her relatives.

Another person claiming to have created the original design for the flag was Francis Hopkinson, a signer of the Declaration of Independence among other occupations.

It appears, perhaps, that Francis Hopkinson designed the rough draft of the original flag with others, including Betsy Ross, making adjustments to the original design. After all design alterations were completed, Betsy Ross then sewed the original Stars and Stripes flag.

19 Fathers Day

The History of Father's Day 2016 dates back to 1910 in Spokane, Washington, where 27year-old Sonora Dodd proposed it as a way to honour the man (a civil war veteran William Jackson Smart) who raised her and her five



siblings alone after her mom died in childbirth. Dodd was at a church thinking about how grateful she was for her father when she had the idea for Father's Day, which would mirror Mother's Day but be celebrated in June, her dad's birthday month.

It is said that she was inspired after hearing a sermon about Jarvis' Mother's Day in 1909 at Central Methodist Episcopal Church, and she therefore told her pastor that fathers should have a similar holiday honouring them. A bill to nationally recognise the holiday was introduced in Congress in 1913.

In 1916, President Woodrow Wilson went to Spokane to speak in a Father's Day celebration and wanted to make it official, but Congress resisted, with the fear that it would just another commercialized holiday. US President Calvin Coolidge recommended in 1924 that the day be celebrated by the nation, but stopped short of issuing a national proclamation.

The holiday gained population during World War II, with most men leaving their families to fight in the war. In 1966 President Lyndon B. Johnson proclaimed the third Sunday of June to be Father's Day. Six years later, the day was made a permanent national holiday when

President Richard Nixon signed it into law in 1972.

City has too many irons in the fire

We need to fix the homeless situation, rail transit and the condition of beaches and waters due to pollution and erosion. Let's get these jobs done first.

The case for stopping rail construction at Middle Street

The city's latest projections to complete rail is nearly \$7 billion, while federal transit officials now project as much as \$8.1 billion.

The question for Hawaii taxpayers is whether the advantages of stopping at Middle Street justify the inconvenience of longer travel times for a very small percentage of commuters.

Here are the pros and cons of stopping rail at the 9-acre Kalihi Transit Center at Middle Street:

First, it would stave off the impending devastation that elevated rail would bring to our waterfront and downtown. It

would prevent Cliff Slater is a Hawaii businessman and 30-year opponent of elevated rail in

Honolulu. this predictive declaration: "In our 100-year history, The Outdoor Circle has seen no other venture that holds the potential to degrade the landscape of Oahu."

Those who have not seen the rail already constructed in West Oahu should visit it. Then imagine rail snaking its way along the waterfront and through our historic downtown supported by pillars that are 8 feet in diameter, the width of a city bus. And imagine the blocklong stations every half-mile all

>> Second, it would eliminate the cost of the most expensive part of the rail project from Middle Street to Ala Moana Center and the likely billions in cost overruns in this final section, which is fraught with environmental and construction difficulties.

It would also eliminate the uncertainty of the cost overruns associated with the unplanned HECO electrical-line clearance requirements in town. All of these inevitable cost overruns would be paid with Hawaii taxes; the federal government contributes nothing to cost overruns.

>> Third, it would reduce the annual operating cost of rail, which the city projects as an additional \$100 million annually, likely understated and likely to be paid for by increased property taxes.

>> Fourth, it would avert future years of traffic congestion that will result from rail construction and lane closings on Dillingham Boulevard, Nimitz Highway and Halekauwila Street.

THE DISADVANTAGE of stopping rail at Middle Street is that instead of being able to continue to Ala Moana Center, commuters would have to transfer to buses to get there or other final destinations.

Still, many public transportation users would take less time to get to their final destination — for example, those going to the University of Hawaii-Manoa by bus from Middle Street would get to UH as fast as any current rail option.

Those working along the King/Beretania corridor are more likely to have faster access to their workplaces by bus because the bus stops are more central to workplaces than the waterfront route that rail would take.

As for project management so far, consider that the Honolulu Authority for Rapid Transportation has spent hundreds of millions of dollars in planning rail but never negotiated a firm contractual arrangement with HECO for required clearances for high-voltage power lines. This omission alone is going to result in hundreds of millions of dollars in cost overruns.

Again, it's come to this: The city's latest estimate to complete rail has reached nearly \$7 billion; the feds are projecting as much as \$8.1 billion. Opponents of rail, who have followed this process closely for decades, believe it will more likely be closer to \$10 billion. Whom do you believe will more likely be right?


