



Civil Beat Excerpt: "State GOP Must Open Doors To Change"

"Hawaii Republican leaders seem more focused on their own survival than revitalizing the party."

Well-respected columnist Victor Craft recently published a piece in Civil Beat, closing with these words about Shirlene:

"But there is hope. Recently, a young and vibrant woman, born and raised in Mililani and who has proved her mettle, is taking a stance and is running for the chairmanship of the party leadership. She is retired Air Force Colonel Shirlene Dela Cruz Ostrov. Yet she faces the good old boy network whose center is self preservation. This policy is proving to be self-destructive. Just count the number of Republicans in the state house and senate."

"It is my sincere hope that in the coming election for the party's chairmanship, games are not played and those who have held the power in the party recognize the need for change. I would ask them to step aside and allow a fresh breeze to blow through the party and revitalize it. If they don't, they just might be out of a job by default."

A Report from our Hawaii Republican Party Treasurer

1. As the Party of Fiscal Responsibility, it is the Treasurer's duty to make the State Committee Members aware of the Party's financial situation.
2. HRP funds are low with only \$21,336.80 in our federal operating account, including all the paid tickets for the upcoming Lincoln Dinner.
Less than \$10,000 is available in the operating account for daily operations. Projected expenses exceed that amount. There has not been any significant fundraising since the Pre-inaugural gala. The sustaining donor program is nearly non-existent. Expenses have exceeded income for months.
3. Oahu's Lincoln Dinner is the largest fundraiser of the year and must garner net income to sustain Party operations for several months or until the next major fundraising event. State Committee members, especially Oahu residents, are encouraged to help the Party sell more tickets to the Lincoln Dinner. If you haven't purchased a ticket or table, do it now. HRP will host a wonderful speaker, Representative Jason Chaffetz from Utah.
4. Lincoln Dinner ticket sales were projected to be \$140,000. Based on this optimistic figure, expenses were set at \$50,000 and the Hawaii Convention Center, with a capacity of 525 attendees, was considered for the venue. The attached contract/license for the Convention Center has a specific payment schedule as listed on page 4 of 14 in the agreement.
These are only the venue expenses. Others are separate.
 - \$2,800 on 7 April
 - \$ 27,000 on 8 April and
 - Final payment - approx \$7263 (due 25 April - 1.5 weeks away)
5. Based on the specified payment schedule and sales, the HRP Treasurer advised against signing the contract/license agreement and recommended looking for a less expensive venue. Some of the payment due dates in the contract/license have already passed. Verbal modifications are not legal agreements. The Party could be liable to meet the terms of the contract, if it were signed. Based on the financial condition of the Party, the high cost of the venue, the written payment schedule, and the low volume of ticket sales, the HRP Treasurer advised the HRP Chairman not to sign the agreement.
6. Lincoln Dinner ticket sales comprise less than \$15,000 actual bank deposits thus far. The HRP Treasurer was told that ticket commitments currently total \$59,100. That figure would net less than \$10,000 for the fundraiser and would cover less than one month's expenses. If more seats are not sold and paid, up to \$35,000 in losses are possible. HRP cannot afford a large financial loss.
5. Based on the aforementioned concerns, the HRP Treasurer made the following recommendations to the HRP Chairman:

a. Cut the monthly budget by terminating salaried positions, currently the Executive Director. According to the employment contract, two weeks notice is required. This could save the Party at least \$4,500 per month.

b. Find a less expensive venue for the Lincoln Dinner and increase ticket sales. Since expenses were projected to be one-third of receipts, overhead expenses should be reduced to \$30,000 or less -- not the projected \$50,000. The goal should be to increase net revenues and decrease expenses.

GRASSROOT INSTITUTE

The Grassroot Institute has just released its latest study on the Jones Act, the 1920's legislation that drives up the cost of shipping. Our report is also a convenient introduction to understanding this issue that heavily impacts Hawaii.

For those of us who have been working to bring change to the Jones Act, realistically there is almost nothing that can be done from Hawaii (or from Puerto Rico, for that matter) to impact the Jones Act.

Say what you will about it, but the Jones Act has proven to be a remarkably resilient piece of legislation. At nearly 100 years old, it is still able to defeat reform efforts ... despite a mountain of evidence that it cripples the economy, fails to achieve its aims and is badly in need of modernization.

As the metaphorical canaries in the Jones Act coal mine, citizens in Hawaii, Puerto Rico and the non-contiguous territories of the U.S. have been some of the loudest champions of reform. Unfortunately, both geographic and political realities mean that an effective reform movement cannot come solely from such exotic places. Even so worthy a poster child as Puerto Rico, with its disparate Jones Act impact, is at a loss for generating sympathy or even much interest in Washington, DC.

What we need to alter the Jones Act is a national and nationwide effort to get Congress to act. Such an enterprise calls for a broad coalition of state policymakers, industry stakeholders, and political influencers at all levels.

President's Corner

To win, we must show how the Jones Act is not a Hawaii problem or a Puerto Rico problem -- it's a national problem with a nationwide impact. That is why the Grassroot Institute is researching how the Jones Act affects the cost of living and the cost of business in all fifty states.

So with all the economic arguments against the Act, what keeps it in place?

The primary argument used by Jones Act defenders is national security. It's a powerful one, even if it is based in nineteenth-century military theory. The problem, as the decline of the American shipping industry and shipbuilders demonstrates, is that the Act has failed in its national security objectives.

But what really keeps the Jones Act afloat is not ideology, but money.

Though reform of the Act is not a strictly partisan issue, the biggest opponent to reform is a partisan coalition representing the maritime industry (and its money), including strong representation from organized labor.

What is needed for effective change is a coalition of reformers, armed with evidence that the Jones Act costs American jobs and hurts American consumers... and money.

Thielen out of date with current issues

State Rep. Cynthia Thielen's commentary was well stated but is not practiced by her or the other GOP elected officials ("GOP needs to return to moderate roots," Star-Advertiser, Island Voices, March 26). There is a lot to be said for being conservative fiscally but liberal on some social issues, particularly in ultra-liberal Hawaii.

While Thielen spent much of her column extolling the federal actions of President Dwight Eisenhower — more than 50 years ago and light-years from today's politics — she said nothing about how to bring that to Hawaii today.

Hawaii needs a conservative GOP now more than ever. The building of a fiscally irresponsible \$10 billion rail system, a \$12 billion underfunded employee retirement system, millions in programs that do not work — such as the GEMS loan program for solar system installation — should have been met with vocal and frequent criticism by Hawaii's GOP, but were not.

Thielen has been a stalwart of the party, but touting federal politics from more than 50 years ago does not speak well for Hawaii's current fiscal quagmire.


