## New energy could revive long-flagging Hawaii GOP Honolulu Star-Advertiser May 16, 2017

Theoretically, in a twoparty system of governance each exists naturally as either the policy-establishing majority or as the opposing minority. In this sense, opposition refers not to obstruction, but to the provision of alternatives — to the lifting of a voice of reason in the face of the potentially corrupting power of the majority. The main body must be held accountable for its actions.

It is patently absurd to imagine that in Hawaii we have had a steady hand substantial enough to hold the majority

accountable any time in recent memory. Republicans currently have a micro-caucus of five elected members who opt muchmore often to vote in favor of the majority agenda than to propose sensible alternatives. Party leadership of late has enjoyed a tenure virtually vacant of any semblance of substance. To suggest that the Hawaii Republican Party is anywhere near capable of fulfilling the role of an opposing minority would be akin to have given Custer's 7th Cavalry any odds whatsoever at Little Big Horn.

In light of Democratic Party dominance in Hawaii for over 60 years, Republicans have over time grown understandably increasingly disenchanted with the prospect of the heavy lifting that it will take to reverse that trend. But it is necessary — no, it is vital — that we engage now with everything that we can muster.

The lack of clearly articulated alternative ideas at the state Capitol has resulted in those formulating policy recognizing no moral conflict whatsoever in taxing us six ways to Sunday to compensate for their many unchecked shortcomings. More than half of us live paycheck to paycheck and at the mercy of an unrivaled cost of living. The growing homeless problem continues to menace our neighborhoods and city streets. And can anyone say with a straight face that there has been any voice of reason to speak of guiding our out-of-control rail project?

Amid internal fracturing and self-soiling that has prevented the Hawaii Republican Party (HRP) from fulfilling its potential, there is a transition quietly taking place that will soon provide a beacon for change.

In March, Republican delegates met at the Honolulu County Convention on Oahu to elect a new county chairman. Brett Kulbis has risen above the clamor and self-righteousness that has mired our party to, in a few short weeks,

## **GRASSROOT INSTITUTE**

Even the Legislature can't seem to figure out what to do about ballooning Rail costs.

In previous columns, I've criticized the lack of dissent that allows tax-and-spend policies to move smoothly through the Hawaii Legislature. But as the session came to a close yesterday, one very controversial bill -- a proposal to raise taxes to help cover the costs of Honolulu Rail -- demonstrated the value of legislative dissent.

To be fair, SB1183 had a pretty tumultuous life as bills go. As it moved from the Senate to the House, it kept evolving. Sometimes it extended the Rail surcharge. Sometimes it adopted special conditions and benchmarks for the county. And for a short period, all it did was eliminate the state's administrative "skim" of the surcharge funds.

But when the bill went to Conference Committee, things got really exciting. Theoretically, this is where differences get hammered out, people come to a compromise, and the legislators present their colleagues with a bill that they can agree on.

Not this time.

The bill that came out of the Conference Committee dispensed with the surcharge in favor of a massive hike in the Transient Accommodations Tax. Determined to find a way to pay for Rail (and perhaps mindful of the fact that the public routinely testifies against raising the excise tax), legislators stuffed the new version of SB1183 with a tax on tourism, a special fund for education, and more.

But when the revised bill went back to the Hawaii House and Senate, the response was anything but collegial. Some said that the new bill was illegal and,

Representatives of the tourism industry spoke out about its effect on the economy and criticized the way it had been pushed through without the chance for public comment. Sen. Kai Kahele spoke from the Senate floor to call the bill "pilau." He also blasted the "privileged few" who passed the bill without transparency or accountability and pushed for an amendment that removed the TAT provisions and extended the surcharge to 2037.

Meanwhile in the House, Rep. Gene Ward blasted the Rail project for being "constipated" and legislators bickered over whether to stick with the Conference Committee's proposal.

The result? Two very different bills from the Hawaii House and Senate. The Senate embraced the suggestion to extend the surcharge while the House went with a (slightly lower) increase in the TAT. But by the time the Legislature completed its 2017 session yesterday, no agreement had been made on how to proceed, meaning the problem of Rail funding may force the legislature to call a special session. Given our track record with special sessions, fiscal conservatives (and fans of legislation that doesn't end up in court) can't be happy about that possibility.

The truth is that the Rail project has put the state in a hole that we can't seem to dig our way out of. Like so many other government projects, it is quickly turning into the kind of boondoggle that excels in sucking down taxpayer dollars, but isn't as good at meeting other goals.

Voting districts on Oahu that up to the point of his election sat dormant and without leadership are now staffed with newly elected and energized district chairs who have in turn appointed new precinct officials.

Old and outdated avenues of communication have been re-opened and modernized. Oahu Republicans who historically have been provided no sense of direction will soon be able to consult a county GOP website for guidance. At the county level on Oahu, HRP is coming to life.

This past Saturday, Republicans convened on Kauai to elect new state executives and selected Col. Shirlene Ostrov as their party leader. It is imperative that Chairwoman Ostrov answer the call for urgent action to revive a party on life support.

Just as Oahu's Chairman Kulbis has provided us reason to rally behind him, so must she demonstrate cause for hope that viable candidates for the legislature will be recruited and supported by the party as a whole.

Time marches on toward the 2018 election cycle, and only time will tell if we are destined through new leadership to achieve our goal of beginning the journey toward becoming a viable opposition party — or if we are to be left to wallow in continued insignificance.


